

City of Haslet Notice of Public Hearing

The City of Haslet, Texas, proposes to annex for the purpose of enlarging and extending its boundary limits so as to include an approximate 4.82 acres of land hereinafter described as:

TRACT 1:

An approximate 4.000 acre tract of land situated in the J. Armendaris Survey, Abstract No. 1764, Tarrant County, Texas, and being a portion of Tract 1 and Tract II to J.R. Deavers, Jr. and wife, Barbara J. Deavers, by deed recorded in Volume 6870, Page 929, Deed Records, Tarrant County, Texas, being the future site of a hotel adjacent to the western right-of-way line of IH-35W on the southbound frontage road/on ramp just south of SH-170.

TRACT 2

An approximate 35,363 square feet (0.812 acre) tract of land situated in the J. Armendaris Survey, Abstract No. 1764 and the J.A. Ashford Survey, Abstract No. 1776, City of Haslet, Tarrant County, Texas, and being a portion of Tract II to J.R. Deavers, Jr. and wife, Barbara J. Deavers, by deed recorded in Volume 6870, Page 929, Deed Record, Tarrant County, Texas being a utility easement between the above described Tract 1 and the Haslet City limits on the eastern right-of-way line of Harmon Road.

A map and this notice will be viewable on the City's web site (www.haslet.org) on or after April 25, 2019. Copies of the map of the area proposed for annexation will also be available at Haslet City Hall, 101 Main Street, Haslet, Texas 76052.

The Haslet City Council will conduct the second of two Public Hearings on the proposed annexation and consider and act on an annexation ordinance on May 6, 2019 at 7:00 pm at the Haslet Community Center, 105 Main Street, Haslet, Texas 76052, for all persons interested in the above-proposed annexation. At said time and place, all persons shall have the right to appear and be heard. Of all said matters and things, all persons interested in the things and matters herein mentioned will take notice.

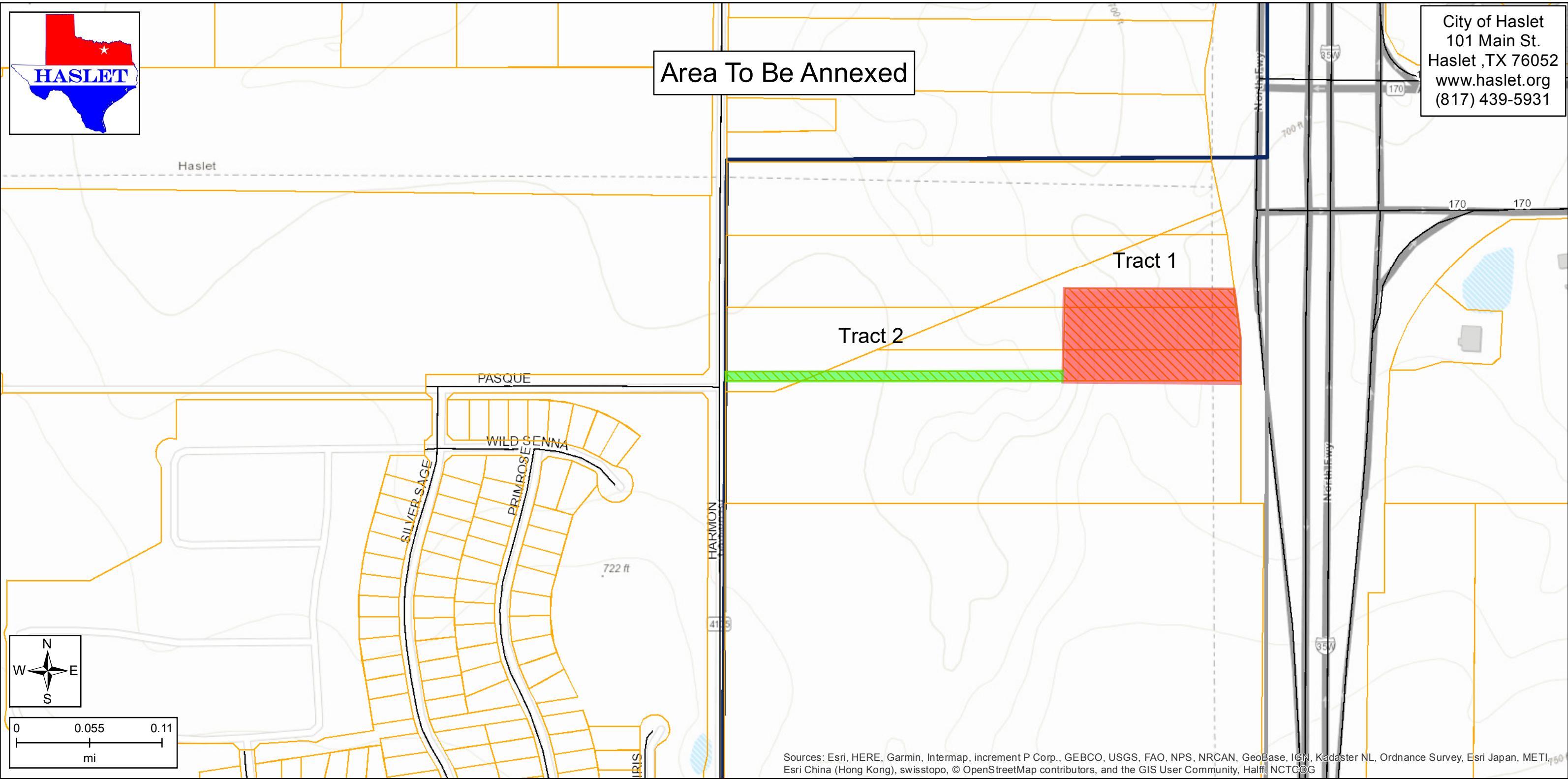
