

**CITY OF HASLET**  
**ORDINANCE NO. 037-2019**

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF HASLET, TEXAS, AMENDING SECTION 2.300(A)(1) OF THE CITY FEE SCHEDULE TO ADD A NEW BASE WATER RATE FOR 6 INCH WATER METERS; PROVIDING THAT THIS ORDINANCE SHALL BE CUMULATIVE OF ALL ORDINANCES; PROVIDING A SEVERABILITY CLAUSE; PROVIDING A SAVINGS CLAUSE; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the City of Haslet, Texas is a Type A general-law municipality located in Tarrant and Denton Counties, created in accordance with the provisions of Chapter 6 of the Local Government Code and operating pursuant to the enabling legislation of the State of Texas;

**WHEREAS**, the master fee schedule of the City of Haslet, has been codified as Appendix A of the Haslet Code of Ordinances establishing various fees for City services; and

**WHEREAS**, the City Council now desires to amend Section 2.300(a)(1) of the City Fee Schedule to establish a new base water rate for 6 inch water meters.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL, CITY OF HASLET, TEXAS:**

**SECTION 1.**

That Article 2.000 "Water Service Fees," Section 2.300 "Commercial, industrial water and outside city limits," Subsection (a)(1), of Appendix A to the Code of Ordinances, the fee schedule, is hereby amended to read as follows:

**ARTICLE 2.000 WATER SERVICE FEES**

Sec. 2.300 Commercial, industrial water and outside city limits

“(a) For commercial and industrial water service, the monthly rates are as follows:

- (1) The minimum payment for service and the first 2,000 gallons:
  - (A) 3/4" meter: \$25.00 base rate.
  - (B) 1" meter: \$50.00 base rate.
  - (C) 1-1/2" meter: \$75.00 base rate.
  - (D) 2" meter: \$150.00 base rate.

- (E) 3" meter: \$300.00 base rate.
- (F) 4" meter: \$600.00 base rate.
- (G) 5" meter: \$1,000.00 base rate.
- (H) 6" meter: \$1,500.00 base rate."

**SECTION 2.**

This ordinance shall be cumulative of all provisions of ordinances of the City of Haslet, Texas, except where the provisions of this ordinance are in direct conflict with the provisions of such ordinances, in which event the conflicting provisions of such ordinances are hereby repealed.

**SECTION 3.**

It is hereby declared to be the intention of the City Council that the phrases, clauses, sentences, paragraphs, and sections of this ordinance are severable, and if any phrase, clause sentence, paragraph or section of this ordinance shall be declared unconstitutional by the valid judgment or decree of any court of competent jurisdiction, such unconstitutionality shall not affect any of the remaining phrases, clauses, sentences, paragraphs and sections of this ordinance, since the same would have been enacted by the City Council without the incorporation in this ordinance of any such unconstitutional phrase, clause, sentence, paragraph or section.

**SECTION 4.**

All rights and remedies of the City of Haslet are expressly saved as to any and all violations of the provisions of Appendix A, the Fee Schedule, of the City Code, as amended, or any other ordinances affecting fees for services which have accrued at the time of the effective date of this ordinance; and, as to such accrued violations and all pending litigation, both civil and criminal, whether pending in court or not, under such ordinances, same shall not be affected by this ordinance but may be prosecuted until final disposition by the courts.

**SECTION 5.**

This ordinance shall be in full force and effect from and after its passage, and it is so ordained.
